The Tenth Finance Committee meeting of Kongunadu College of Engineering and Technology was held in the Board Room on 13.04.2026 at 03.30 P.M.

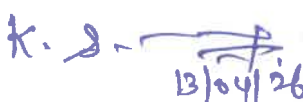
